VOTER DATA OPTIONS

The following information is available upon request and provided from the database as it exists on the day of the request. The data can be provided by precinct, district, race, party affiliation, age, gender, etc. The information can be exported in CSV, Excel, Label, Text or PDF formats to any requestor.

To obtain the information below, please complete the **Voter Data Request Form** on pages 3-4 or contact our office.

Pursuant to FS 119.07, Inspection and copying of records; photographing public records; fees; exemptions, specified classes of professionals (current or former) can submit a written request to exempt their voter information from public records. **These names will not be included in the information you receive.**

- **Label Format(s):** Labels are designed for Avery 5161 label sheets (4" x 1" laser labels, 20 labels per sheet). The following options are available in label format:
 - **Each Registered Voter:** This option provides a printed label for each registered voter. Information includes a voter's registration number, precinct number, voter name, residential or mailing address, city, state and zip.
 - **Household Options:** Select from the two options provided below to achieve a cost efficient tool that will reduce the number of labels printed and the amount of postage incurred when mailing distributions:
 1. **To the (last name) family:** A label is produced with the last name of each family living at the same residence or mailing address (if applicable).

OR

2. **To the registered voters at:** One label is produced for the residence or mailing address (if applicable), regardless of the number of families within a household with different last names.
- **Registered Voter List *without* Voter Election History:** A list of registered voters will include columns containing the information outlined in the *Guide to the Data File* located on pages 7-8. The option to select from the *Household Option Format*, noted above, can be applied.
 - **Registered Voter List *with* Voter Election History:** A list of registered voters will include columns containing election history and the method a voter used to vote in addition to the information outlined in the *Guide to the Data File* located on pages 7-8. To select specific election(s), please complete the *Nassau County Voter Election History Form* located on page 5. One election history file can include up to 20 elections.
 - **Walking List:** A list of voters in door-to-door order.

GUIDE TO THE DATA FILE

The following guide provides information contained in the data fields for voter information files. **Please note:**

- The **“Formatted Address”** column contains the mailing address (residential, P.O. Box, etc.) for the voter and is to be used for mailing purposes.
- The **“Residence Address”** column is the physical address of the voter and may not be the mailing address.
- The **“Mailing Address”** column will be populated if a voter has provided a mailing address different from the **“Residence Address.”** Otherwise, the column will be blank.

FIELD	DESCRIPTION
"VoterID"	Unique voter registration ID number
"Voter_Name"	Last name, name style (SR, JR, III, etc.) first name, middle initial
"Last_Name"	Last name
"First_Name"	First name
"Middle_Name"	Middle name
"Name_Style"	Name style (SR, JR, III, etc.)
"Formatted_Address" * *Refer to "Mailing_Address_1"	First line of mailing address. If the voter provided no mailing address, this field contains the first line of the residential address. Street number, street number suffix, street direction, street name, street type, street direction suffix, apartment number. For example: 2345A S MONROE ST 67B where A is the street number suffix, S is the street direction, and 67B is the apartment number. For example, for a street with a direction suffix, the address might be: 4234B SHAMROCK RD E
"City_State"	City and state of mailing address. If the voter provided no mailing address, this field contains the city and state of the residential address.
"Zip_Country"	Zip/postal code and/or country of mailing address. If the voter provided no mailing address, this field contains the zip/postal code and/or country of the residential address.
"Residence_Address"	Street address line of residential address
"Street_Number"	Street number of residence address
"Street_Number_Suffix"	Street number suffix of residence address
"Street_Dir"	Street direction of residence address
"Street_Name"	Street name of residence address
"Street_Type"	Street type of residence address
"Street_Dir_Suffix"	Street direction suffix of residence address
"Unit_Type"	The type of unit, such as APT or BLDG.
"Apartment_Number"	Apartment number of residence address
"Zip_Code"	Zip code of residence address
"City_Name"	City name of residence address
"Mailing_Address_1"	Where the voter has provided a mailing address, the <i>Formatted Address</i> field contains it. Otherwise, the <i>Formatted Address</i> and <i>Residence Address</i> are identical. For Vote by Mail requestor information (for authorized requestors only), this field may contain a specific mailing address for balloting purposes.
"Mailing_Address_2"	Second line of mailing address.
"Mailing_Address_3"	Third line of mailing address. If the voter does not have an entry in Line 3 of their mailing address, the mailing city, state and zip will be consolidated in this field.
"Mailing_Address_4"	If voter's mailing address has a value in the Country field, the value will be inserted in this field.
"Mailing_City"	Mailing address city
"Mailing_State"	Mailing address state
"Mailing_Zip"	Mailing address zip or postal code
"Mailing_Country"	Mailing address country

Note: In elections prior to 2006, the codes B and P were not used. B was included in Y and P was included in N. Early voting began in 2004; the first election in which you will see the code E is the 2004 General Election. The codes F and Z were introduced in early 2010 to represent provisional ballots marked at early voting sites and the polls, respectively, which were later tabulated. Prior to implementation of these two codes, tabulated provisional ballots were included in codes Y (for provisional ballots at the polls) and E (provisional ballots at early voting).

"Sex"	M = Male, F = Female, U = Unknown
"Birth_Date"	Date of voter's birth in MM/DD/YYYY format
"Registration_Date"	Date voter registered to vote in MM/DD/YYYY format
"Congressional_District"	Voter's US Congressional district
"Party"	Voter's political party affiliation. For example, DEM = Democrat, REP = Republican, NPA = No Party Affiliation. Florida Political Parties are subject to change. Please refer to the Division of Elections Website (link below) for the most current list of the Florida Political Parties: http://election.dos.state.fl.us/candidate/parties.shtml
"Precinct"	Voter's precinct
"House_District"	Voter's Florida House district
"Senate_District"	Voter's Florida Senate district
"Commission_District"	Voter's county commission district
"School_Board_District"	Voter's school board district
"Assistance_Required"	Y= assistance required to vote; N= assistance not required
"Mailing_Address_Flag"	Set to Y if the voter has a mailing address
"City_Code"	City code if voter resides within a city
"City_Ward"	City ward or city precinct
Telephone_Number	Voter's telephone number with area code, if provided
Voter Status	Voter's registration status
Public_Email_Address	E-mail address on file, if voter requested sample ballots to be e-mailed (upon request)
Sample_ballots_by_Email	If voter requested sample ballots to be e-mailed: Y = Yes; N = No; Blank = Not Applicable at the time voter completed Florida Voter Registration Application
<i>20 voting-history fields</i>	Appears in export file only when the Output Option is Text File with Voting History . Consists of 20 voting-history fields, each with a field header containing the election name and date. For example: General_ElectionNov42008
The following codes are used in the voting-history fields to specify whether and how the voter voted. The codes are listed in order of precedence. So if multiple conditions exist, the condition with the highest precedence will be shown. (In earlier versions of Voter Focus, if a voter's provisional ballot was not counted and they voted in another manner, the provisional ballot took precedence.)	
Y	Voted at the polls
Z	Voted at the polls by provisional ballot (ballot was tabulated)
N	Did not vote
A	Voted absentee (includes referred ballots that were tabulated)
B	Absentee ballot rejected by canvassing board (not tabulated)
P	Provisional ballot rejected by canvassing board (not tabulated)
X	Ineligible to vote
E	Early voted
F	Early voted by provisional ballot (ballot was tabulated)
<blank>	Not registered at the time of the election or information not available
